

EXPRESSION OF INTEREST

The Common Effluent Treatment Plant (CETP) project is sanctioned by Department of Industrial Policy & Promotion (DIPP), Ministry of Commerce and Industry, Government of India and executed by VACDCL.

The CETP is completed in all respects and the plant is in operation. The capacity of the Plant is 200 KL per day. The necessary clearances from APPCB i.e., Consent for Operation is also obtained. In this connection it is proposed to call quotations from interested parties to operate Common Effluent Treatment Plant on OUTSOURCING BASIS.

Regulations:

1. The Contractor can get effluent from anywhere but should treat the effluent as per the regulations and acceptance of APPCB. He should not discharge the treated effluent in any drains or canals which is not permitted. The collection norms and delivery norms of Treated Effluent should followed as per APPCB regulations. He should also get any licenses required on the name of VACDCL. The requisite charges to be paid to APPCB OR Environmental offices will be paid by VACDCL.
2. The licenses strictly be in the name of VACDCL only. The contractor holds full responsibility for maintaining and submitting requisite records to be filed weekly, fortnightly, monthly, yearly etc. to VACDCL / APPCB.
3. Treatment charges to be collected from the parties should not exceed Vijayawada Municipal Corporation charges and should have prior approval of VACDCL.
4. As the facility was promoted by user contribution received from the industries, the promoter users shall be given discount on treatment charges as decided by VACDCL.
5. The discharge must be done as per the directions of APPCB at the cost of the contractor duly submitting the details every week to VACDCL.
6. If the contractor is found violating the rules and regulations of APPCB OR the conditions of this Memorandum of Understanding. VACDCL reserves the right cancel the agreement / terminate / reduce period of agreement with a short notice of one month.
7. The Assets taken over by contractor, be maintained in good condition and should be handed over back in good running condition with all the fixed assets. The Managing Director of VACDCL OR any person designated by the Managing Director should have free access for inspection of the CETP. VACDCL shall not provide additional equipment / construction required for running the plant and such arrangements have to be made by the contractor only.
8. During the agreement period Maintenance and up-keeping of all equipment of the facility shall be borne by the contractor.
9. The complete monitoring authority shall be VACDCL.
